Memorandum of Agreement for Renewal of License for SPRS Software Solution and AMC

I. Purpose of the Agreement

This Memorandum of Agreement (MOA) sets out the terms by which **SRI MANASA SOLUTIONS, Tenali** (henceforth, the *Solutions*) and **AG&SG College Vuyyuru (Autonomous)** (henceforth, the *College*) for renewal of license for use of software solution namely the **Students' Performance Review System** (henceforth the **SPRS**), that was earlier developed, customized and implemented by the *Solutions* for use by the *College*.

This agreement will come into force with effect from 24-Aug-2018. **1. Sri Ch Krishna Mohan 2. Sri J.S.N RAJU** will be the key contact persons for the *Solutions* for this assignment. **Principal or the person delegated by him** will be the key contact person for the *College* for this assignment. These individuals are responsible for ensuring the smooth implementation of license extension and conduct of the activities enumerated below.

With reference to the mail dated 24-Aug-2018 from the *College*, where in the college expressed interest to *Solutions* for extension of license for the **SPRS** software for a period of another 5 years and to which the *solutions* has agreed to extend the license for an additional period of 5 years under the payment and other conditions as stated below.

Through this agreement, the **Solutions** has agreed to extend the license of the customised software solution for SPRS for a period of another 5 years which was initially licensed for a period of 5 years.

Charges for renewal of License and other conditions:

The Solutions has agreed to extend the license of SPRS software solution for a period of 5 years on payment of Rs. 30,000/- (Rupees Thirty thousand only) plus GST as applicable and stipulated by the Government of India (GOI) from time to time, by the college to the Solutions. In addition, the Solutions shall charge Rs. 10,000 per year plus GST towards AMC (Annual Maintenance Charges). The *College* shall pay the AMC amount of Rs 10,000/- plus GST every year to the *Solutions*. Out of the license renewal amount of Rs. 30,000/- plus GST, an initial amount of 75% of the renewal license fee plus GST shall be paid at the time of renewal and the remaining balance within three months.

II. Roles and Responsibilities

A. Responsibilities of the *Solutions*:

Renewal of license for the software solution of SPRS containing the following Components/modules:

- **Student Registration**
- **Examinations Maintenance**

- Courses Maintenance
- Examination Fee Maintenance
- Examination Application Printing
- Generating Nominal rolls
- Hall Tickets Generation
- Coding and decoding
- Marks Maintenance
- Generating checklist , awards list, D-form
- Different levels of students history tracking
- Various reports according to your requirements
- SMS Module for Existing Service
- Publishing results on college website

The Solutions will give the license to the College to use SPRS for a period of **FIVE** years (from August, 2018 to July 2023). Further, the Solutions will provide the AMC to the *College* for the maintenance of the SPRS software solutions as and when required for which the *college* shall have to pay to the *Solutions*:

1. The AMC charges of Rs. 10,000 (Ten thousand only) every year.
2. Necessary modifications/additions, if required, to the initially-provided features of SPRS at an additional cost based on the work content.
3. The travel and incidental expenses of contact persons from *Solutions* will have to be borne by the *College*.
4. The *Solutions* will have to respect the confidentiality of the *College* data which should not be passed on to a third party under any circumstances. This will be viewed by the *College* as a breach of the Agreement.

B. Responsibilities of the COLLEGE:

1. The *College* will identify a responsible person to liaise with the Solutions and provide the needed requirements for the customisation of SPRS.

2. The *College* will arrange the computer system(s) with required configuration and OS for installing the SPRS in the College.
3. The *College* will identify a person from their staff as a point of contact for the maintenance issues.
4. The *College* will bear the site visit costs, if any, to be made by the *Solutions* for reinstallation of SPRS software due to computer hardware issues of the College.

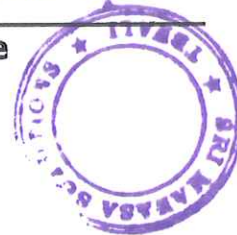
